### OUR FIRST 10 YEARS: 1993-2003

1993 \*The Society was founded by citizens of Round Top and nine members were chosen for the Board of Directors because of their interest in preserving the history of the Round Top area.

The land and the building to be used as the home of the Round Top Area Historical Society was graciously gifted by Lillian Kroll Thomas and Ruby Kroll on January 29, 1993. It was deeded to the Town of Round Top for the specific purpose of being used as the historical center.

The Society by-laws were approved by the Board of Directors on Feb. 23<sup>rd</sup>. The Mayor of Round Top and the Town Historian are members of the Board of Directors as per the by-laws.

The Society was incorporated May 3rd, Charter No. 01269568.

Application to the I.R.S. for Not-For-Profit tax-exempt status was temporarily approved on May 10th.

1994 \*Total renovation of the historical center was begun in February.

The first issue of the Round Top Are Historical Society newsletter, Facts & Artifacts, was published in the Spring. Editor: Herb Diers.

Donations, artifacts, historical memorabilia, etc. were solicited. Displays were prepared to present to the public a semblance of the Round Top area history.

An "open house" was held on May 7th with all the community invited.

Renovation of the historical center was completed in November.

November 19th: First day open to the public.

The first amendment to our by-laws was approved in September. It added another category called "Honorary Membership" in Article III. The Board of Directors has the authority to bestow this special honor by a two-thirds vote.

1995 ★The Society's first large scale fund raiser held on February 18th and 19th was a tremendous success. Labeled as a "Community Garage Sale" it received participation from almost all of Round Top's citizens.

The <u>Grand Opening</u> of the historical center was held May 6th. This grand occasion was the forum for presenting the plaque dedicating the building and land generously gifted by Lillian Kroll Thomas and Ruby Kroll. Mayor Dave Nagel thanked Lillian and Ruby on behalf of the Town of Round Top and unveiled the plaque which bears the inscription: *This building and land, a generous gift from Lillian Kroll Thomas and Ruby Kroll, was accepted by the Town of Round Top for the express purpose of housing the Round Top Area Historical Society, Inc. Their gift is gratefully acknowledged and deeply appreciated by all with an interest in preserving our history.* 

1995 was the 125th year of Round Top's incorporation. This milestone was celebrated by all of Round Top's citizens and friends on September 30th. A special exhibition was on display at the historical center entitled:

ROUND TOP: THE FIRST 125 YEARS
A retrospective commemorating the 125th anniversary of the incorporation of the Town of Round Top

1996 ★The second annual "Community Garage Sale" took place on Feb. 17th & 18th and it was very successful with large donations and terrific community response. As the community interest grows in preserving its history, a larger facility will be needed. The community was fortunate in having the beneficence of its citizens to enjoy a great beginning. Immense funds will be needed to increase land space and building capacity.

Additional land acquisition was approved by the Board of Directors and 1,441 square feet of land was purchased by the Society adjoining the current facility to the east.

An add-on to the rear of the historical center of 460 square feet was completed. This space will afford more room for office and storage.

The Pioneer Arts Foundation sponsored Round Top's first "Arts Festival" in November. The Society participated by having a hot dog and nacho stand as a fund raiser.

1997 \*The third annual "Community Garage Sale" was held Feb. 15th & 16th. It was very successful with all of Round Top and friends of Round Top donating and buying. The Society was especially grateful for the matching fund received from Lutheran Brotherhood

The Texas Historical Foundation through the Jeanne R. Blocker Memorial Fund provided a \$1,000 grant for the floor and roof restoration.

A new concrete floor and a new insulated metal roof were installed.

A photocopier and a computer were purchased to handle the Society business more efficiently. Both were used, but in very good condition.

The Society participated in the second annual Arts Festival by having a hot dog and nacho stand as a fund raiser.

1998 ★The fourth annual "Community Garage Sale" was held Feb. 14th & 15th. The outpouring of donations and purchases again exceeded the year before.

Two new bookshelves and a lighted display case were purchased. The interior walls and the restroom were completed. The Internal Revenue Service approved our permanent status as a tax-exempt Not-For-Profit organization.

The flagpole donated by the Town of Round Top was installed along with a plaque commending past mayor Don Nagel and historian John Banik for their many years of faithful service to our town.

Pat Wood donated one acre of land for the use and benefit of the Round Top Area Historical Society. It is situated at 397 E. Mill Street directly behind the Round Top Post Office. Also, an easement for ingress and egress to this one acre was granted.

The by-laws were changed regarding board members. Article IV changed by reducing the number of board members from nine to six and a board member may serve three consecutive terms of three years each instead of two terms.

The Mayor and Town Council of the Town of Round Top issued a proclamation commemorating the year 1998 as the 150<sup>th</sup> (Sesquicentennial) Year since Round Top began. The Round Top Area Historical Society promulgated the proclamation.

The Society sponsored and produced the first Christmas Tour of Homes and Historic Places for Round Top. Homes and places on the tour: Fricke-Cies House, Hoffmann-Wood House, Umland-Diers House, Schiege-Johnston House, Colonel Moore's Fort, Bethlehem Lutheran Church and the Round Top Area Historical Society Center.

1999 ★The fifth annual "Community Garage Sale" was held on Feb. 13th &14th. Again, many donations and puchases from Round Top citizens and friends resulted in a very successful fundraiser.

The Society sponsored and produced the second annual Christmas Tour of Homes and Historic Places. Homes and places on tour were: The Historical Center, General Store, Etzel-Tubbs House, Maddock House, Joh-Kahn Log Cabin, Bethlehem Lutheran Church

The Bodo Kraus house was donated to the Society by the Kraus Estate and situated on the Wood Annex behind the post office. Restoration on it will begin next year.

The Society is in discussion with interested parties with the idea of moving the Connersville Baptist Church building to the Wood Annex. It now is located next to the Richter Cemetery on FM 1457. Approval from the town council is being sought in light of the new Land Use and Architectural Controls for the Town of Round Top.

Round Top's new post office was dedicated 4-22-99. A framed copy of the Sesquicentennial Proclamation was presented by Mayor Dave Nagel and it now hangs in the post office. The Round Top Area Historical Society is credited with promulgating the proclamation.

2000 ★The sixth annual "Community Garage Sale" was held on Feb. 19<sup>th</sup> & 20<sup>th</sup>. As in the previous years the participation, both in donations and buying, was tremendous resulting in a very successful event.

The Society sponsored and produced the third annual Christmas Tour of Homes & Historic Places on Dec. 2<sup>nd</sup>. Homes and places on tour were: The Historical Center, Huth House, Sharon Green Baker House, Winklemann-Travis House, Tillman House, Bethlehem Lutheran Church

The Kraus Haus now situated on the Wood Annex has undergone complete restoration....new roof.... new windows, etc.

The Town of Round Top has approved the request to move the Connersville Baptist Church onto the Wood Annex.

Major donations during the year: Pat Wood gifted an additional .248 acre of land to the Wood Annex, Leon & Dot Twiford donated an old printing press, Lydell & Gary Brown donated Johann Traugott Wandke's wooden woodworking lathe he brought from Germany in 1855.

2001 ★The seventh annual "Community Garage Sale" was held on Feb. 17<sup>th</sup> & 18<sup>th.</sup> This social and fun fundraising event continues its success with everyone in Round Top participating. A wonderful outpouring of donations were collected and almost all were sold. Another great success!

This was the fourth year for the Christmas Tour of Homes & Historic Places held on Dec. 1<sup>st</sup>. Another very successful event sponsored by the Society. Homes and places on tour were: The Historical Center, Wolf House, Wolff-Rather House, Kraus Haus, Joseph George Wagner Haus, Bethlehem Lutheran Church.

A fifth category was added to our by-laws in Article III-Membership, "Lifetime Member - \$1,000". It is a single dues payment of \$1,000. If a membership includes a spouse, it is for the lifetime of both.

Major donations during the year: The Kraus Estate donated additional personal items to be displayed in the Kraus Haus, The Do Your Duty Club donated \$5,000 for the furtherance of preserving Round Top history, David & Mary Collins donated \$2,500 toward the moving and restoration of the Connersville Baptist Church.

Work continues on the improvement of the ground, parking space, trails and other amenities for the Wood Annex. Two live oak trees were planted. A water meter was installed. Moving the Connersville Baptist Church and building a pavilion on the annex are items under consideration.

A brochure depicting a brief history of Round Top as well as describing the beginning of the Round Top Area Historical Society was produced during the year. It is also a solicitation for membership in the Society.

2002 ★The eighth annual "Community Garage Sale" was held this February 16 & 17<sup>th</sup> in the Round Top Town Hall. It was another great success.

The fifth annual Christmas Tour of Homes & Historic Places was held December 7. Homes and places on tour: The Round Top Area Historical Society center, Knutzen Haus, Log Cabin on Bybee Lane, Rummel Haus, Hornberger House, Bethlehem Lutheran Church.

Work continues on the Wood Annex in shaping and building the padsites for the future pavilion and the Connersville Baptist Church. Connersville Baptist Church will be the new museum for African-American history in and around Round Top.

The John F. & Helena Knutzen Haus has been donated by Douglas Knutzen. It is an early Texas farmhouse built in the latter 1800's. The Knutzens reared a family of seven children, four boys and three girls, in this house.

The 1905 Fire Pumper has been donated to the Society by the Round Top-Warrenton Fire Department. It has been accepted by the Society and is planned for display.

Changes to the by-laws: Amendment III now states that a director may not be elected to succeed himself/herself if such director has served four consecutive three-year terms. Also, Article V changed such that each person shall serve one-year terms unless re-elected but shall not serve more than four consecutive one-year terms.

2003 ★The ninth annual "Community Garage Sale" was held February 15 & 16<sup>th</sup> in the Round Top Town Hall. This exciting event has become an exceptional fundraiser for the Society. This year was the most successful ever.

The sixth annual Christmas Tour of Homes & Historic Places is planned for Saturday December 6<sup>th</sup>. Tickets will be sold in advance in hopes to boost the success of the event. Ticket holders will be entered in a raffle

The Connersville Baptist Church was moved to the Wood Annex this spring. A grant application was submitted to LCRA on September 30<sup>th</sup>. Renovation of the building is planned for the upcoming year. David Collins has worked diligently on achieving this milestone for the Society. The grant proposal was prepared by PTI, Inc.

An 1880's log cabin was gifted by Reese & Darla Schmidt and was moved to the Wood Annex for restoration.

The 1905 Fire Pumper was displayed on the Fourth of July.

The Knutzen Haus was moved by Douglas Knutzen to his farm for family restoration.

The Society purchased a new copy machine and a steel shipping container to store garage sales items throughout the year.

David Collins donated a new computer.

The society by-laws were changed regarding the number of board members. The board of directors shall consist of eleven individuals to serve four three-year terms. This is now Amendment VI to the by-laws. Article IV was changed which now states that the Board of Directors shall consist of eleven individuals. This is now Amendment VII to the by-laws.

New members of the board: Michael Cies, Rose Diers, Frances Harris, and Peggy Warnock. Ruth Menking took the place of Herb Diers as secretary after his passing in April.

New Historical Center hours: Friday and Saturday 12-3pm.


## NEWS & UPDATES

New members of the Board are Michael Cies, Rose Diers, Frances Harris, and Peggy Warnock


Dur by-laws were changed to allow for eleven individuals to serve for four three-year terms on the Board of Directors
