
FIRST PLAN OF ROUND TOP

By F. H. BELL, Surveyor - 1854

William Caruthers drew a plan for the Village of Round Top on 3-21-1850. It is alluded to in FCDR, Vol. 37, Page 77, but it has never been located.

This is a reduced size, partial copy of Bell's 1854 survey.

Round Top's "General Store" is situated on Lot 2, Block 19. Note that F.H. Bell had written in the name, Ledbetter.

John Shults became the third United States postmaster in the area on 7-19-1848. He immediately moved the post office to his land (present day Round Top) and simultaneously changed the name to Shults Store. On 11-30-1848 the name of the post office was officially changed to Round Top.

The La Bahia Road came through Round Top from two directions to the east and proceeded across Cummins Creek toward La Grange. One of these trails closely followed what is 1457 today, coming in from the stage stop referred to as "Old Round Top Place." The other ran along a line what today is SH 237. They intersected somewhere between the town hall of today and Cummins Creek.

In 1848 John Shults and his father, Christley, owned three-fourths of the land that is Round Top today. The other fourth was owned by Myers Fisher Jones. Across Cummins Creek to the west there was a stage stop operated by Stephen Townsend.

On 9-20-1851 John Rufus Alexander, son-in-law of M.F. Jones, sold seventy acres of land to Hugh White. It is on the southwest corner of this seventy acres that the "general store" was built. Today, it is directly across SH 237 from the town hall at the corner of Mill Street.

The plat of Round Top shows it as Lot 2, Block 19. The sequence of ownership from the granting of the headright to James Winn is as follows:

References to County Clerk's and District Clerk's letters provide authentication. The letters are on file at the Round Top Historical Center.

Neither Myers F. Jones nor J. R. Alexander ever sold land to J. A. Ledbetter. See County Clerk's letter dated 5-10-99. Also reference Vol. O, P. 283 (Ledbetter to Kleinert) dated 1-28-1860 where it states, "to the northwest corner of J. A. Ledbetter's Lot #3 in Block No. 19."

On 1-28-1860 J. A. Ledbetter owned all of Blocks 19 and 22.

Hugh White 350 acres in several tracts.

to L/520 The deed states, "except so much thereof as has been Charles P. Flack 1-19-1857 included in said Town or Village of Round Top."

Reference District Clerk's letter dated 3-21-99 where it is verified there were no court cases against Melvina or Hugh White.


J. A. Ledbetter did buy Lots 2 & 3 in Block 21 from C. P. Flack on 7-4-1857 for \$1,050 (M/163). That price would have been about right if a building existed. Bieberstein's map of 1877 did indicate two buildings on Lot 2, Block 21, but that's over twenty years later.

So, with the ambiguous information pertaining to Lot 2, Block 19 and the fact there are no recordings of the transactions between White, Flack and Hodge to or from J. A. Ledbetter, there is no certain way it can be determined who built the "General Store" and when.

An educated guess would place its beginning from 1851 when Hugh White became owner of the acreage. Inasmuch as the date that J. A. Ledbetter became owner of Lot 2 is not known, but considering the fact that F. H. Bell put the Ledbetter name on it in 1854, it can be assumed the "General Store" was built between 1851 and 1854, most probably by J. A. Ledbetter.

John Alexander Ledbetter was the oldest son of Hamilton and Jane Ledbetter, born 12-27-1830. Hamilton Ledbetter moved into the Round Top area on July 17, 1850, when he purchased 536 acres of land (G/390) in the area that today encompasses the Richter Cemetery. John, more often called Alex, never married. He was killed while on sentinel duty in the Civil War at Vicksburg. He was a captain in Waul's Legion.


